#### What can you do?

## **Establishing the Right to Life**

The Personhood Amendment is the only plan to end abortion in Kansas. It simply states that: "Kansas shall hereby guarantee the inalienable rights, equal protection and due process of law of every human being from the beginning of the biological development of that human being, including fertilization."
